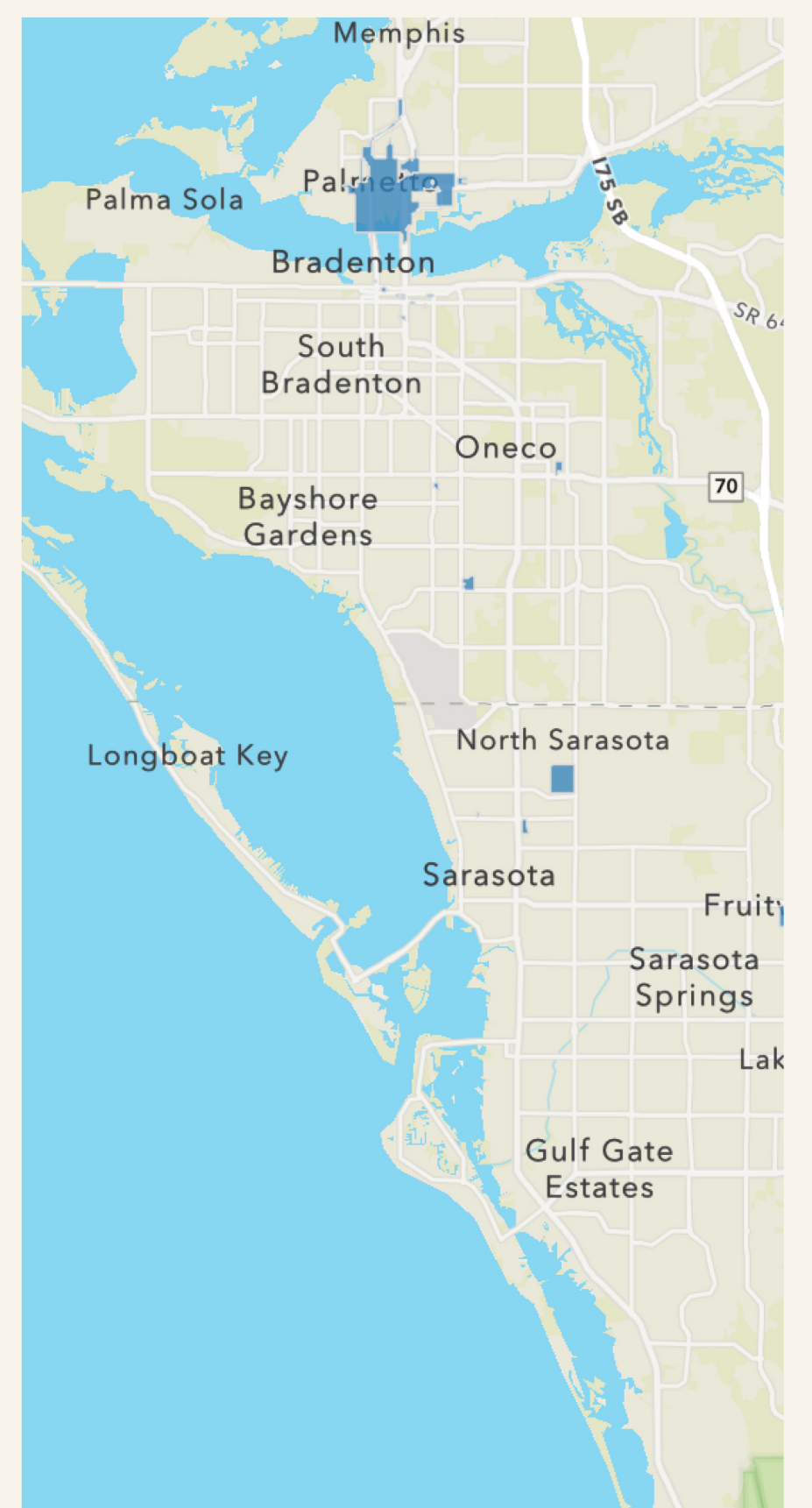

Dr. Christian Wells

Professor and Director Center for Brownfields Research & Redevelopment Anthropology and Director of the Center for Brownfields Research & Redevelopment at the University of South Florida. Served previously as the Founding Director of the Office of Sustainability and as Deputy Director of the Patel School of Global Sustainability. Currently an Interdisciplinary Research Leader with the Robert Wood Johnson Foundation, and immediate Past-President of the Florida Brownfields Association, the state's largest nonprofit advocacy organization dedicated to brownfields redevelopment and environmental justice. Applied environmental anthropologist with an interdisciplinary background in the social and natural sciences. Maintains a diverse portfolio of research projects aimed at improving human and environmental health outcomes of re/development efforts in underserved communities. Current research emphasizes environmental justice, brownfields challenges, land use legacies, sustainable and equitable development, water/wastewater management, and science-policy interactions.

Associate Professor of Architecture and Urban Design Research includes urban/community design planning, economic development/community revitalization, housing/residential development strategies and development regulations. Associate Professor of Architecture and Urban Design, teaches architectural design and urban/community design studio courses, and seminar courses on housing and community design at the University of South Florida's School of Architecture & Community Design. Areas of research include urban/community design planning, economic development/community revitalization, housing/residential development strategies and development regulations. He has developed community revitalization strategies and urban design plans for a number of Florida communities. His community service record includes membership on the Hillsborough County Affordable Housing Steering Committee, Hillsborough Habitat for Humanity and The Children's Museum of Tampa board of directors. His professional work has been recognized by the Central Florida Chapter of the American Planning Association.
